

A little about me...I am a mother of two teenagers, a 17 year-old girl and a 16 year-old boy and I am very proud of them. I own a pet grooming shop



# Know Your Rights: Mail in Prison November 13, 2003

The Supreme Court has held that the First Amendment of the Constitution entitles prisoners to receive and send mail, subject only to the institution's right to censor letters or withhold delivery if necessary to protect institutional security, and if accompanied by appropriate procedural safeguards. Thus, institutions should have a rational security reason for every restriction placed on the receipt or sending of correspondence – be it the limited number or length of letters received by inmates or what cannot be sent to the inmates.

If the institution cannot present a rational security reason for a restriction, then the restriction should be challenged. However, an institution may have the authority to read certain inmate's mail if it has probable cause to believe the inmate is conspiring with persons outside the prison to traffic in contraband or to arrange a breakout.

It is important to remember that any "arbitrary opening and reading of . . . mail [with] no justification—other than harassment" may violate the First Amendment. Prison officials' ability to inspect and censor mail depends on whether the mail is non-privileged (commercial mail), "privileged" (attorney-client mail), or "general" correspondence (letters from family members, friends, and businesses).

#### Non-Privileged Mail

The Constitution permits incoming non-privileged mail to be opened outside the inmate's presence. Prison officials can read non-privileged mail for security or for other correctional purposes without probable cause and without a warrant. Business and commercial mail may be treated as non-privileged; disagreements exist, however, regarding whether or not mail to and from the media is privileged. Some courts restrict the reading of outgoing mail.

Although some prisons have sought to restrict inmates' access to downloaded information from the Internet, courts have held that inmates can receive snail mail that contains Internet-generated information.

#### **Privileged Mail**

"Privileged" mail is entitled to greater confidentiality and freedom from censorship. Privileged mail may be briefly held to verify the identity of the addressee. In order for mail to be treated as privileged, it must be clearly marked. Privileged mail may be checked for contraband but cannot be read in the ordinary course of prison routine. The "contraband" check must be conducted in front of the inmate. Outgoing privileged mail may generally be sent unopened.

Some courts have also accorded privileged status to mail to and from various public officials and agencies of state, local, and federal government.

What Can a Prisoner Do If Privileged Mail is Opened Outside an Inmate's Presence?

An inmate may choose to file an action in federal court concerning a single piece of legal mail that was opened outside his/her presence; however, a court will probably dismiss the case. This is not because an inmate's rights were not violated, but because a federal court may rule that a prison receives a large volume of letters each day and may make a mistake once in a while. On the other hand, a court may not dismiss the lawsuit if there is a showing that the



inmate was actually harmed by the opening of the letter outside the inmate's presence. Examples of actual harm would be if the prison official's policy is to open all privileged mail outside the recipient's presence, if the letter is copied, or if information contained in the letter is used against the inmate.

When an inmate receives a piece of privileged mail that has been opened outside his/her presence, s/he should file a grievance. It is difficult for prison officials to deny that this error did not happen since most prisons require an inmate who receives privileged mail to sign for it or a guard to sign a book to acknowledge that the inmate received the mail. Usually, prison officials will admit that they erred, and that such accidents will not occur in the future. The inmate should keep a copy of this grievance in case this act happens again. If the error happens again, the inmate should file another grievance, mentioning the previous one and the prison official's response. If s/he can establish that the prison has a policy to open privileged mail outside the recipient's presence, then the inmate may win a lawsuit.

#### **Dignified Death?**

*"The policy of lethal injections is to carry out the death penalty in a professional, humane and dignified manner." - from Administrative regulation, Colorado Department of Corrections* 

Professional manner? Is it professional when a trained physician participates in a procedure to end someone's life? The Hippocratic oath sworn by every doctor states, "I will give no deadly medicine to anyone if asked, nor suggest any such counsel." This oath seems to be ignored for what may be their own personal opinions about the death penalty. Is that what we call professional?

Humane? Is it humane to end someone's life? Is it equally humane to assist in the procedure of execution? This would be a capital crime in most states. Who is lethal injection more humane for? Is it possible that it looks cleaner for the witnesses and the staff? Surely it is less dramatic to witness than execution by electricity, hanging or shooting, but this 'humane' form of ending someone's life is overall a much longer process for the condemned (30 - 45 minutes from the strapdown to the gurney till they are dead – IF they are able to find a vein). How many lives do they live in those long minutes? Is it more humane to subject a human being to this anguish? Is it humane to be strapped down and a gurney, stuck by needles and know that soon – soon – soon your life will be over. Is it humane to draw the curtains aside to let people witness the last breath?

Maybe that is what is called dignified manner? Recently Ohio let the witnesses observe the entire execution – from the walk to the gurney till the bitter end. I wonder if the guards and witnesses are left with thoughts like "professional, humane and dignified manner" after watching a condemned man fight, beg and plead for his life.


Personally I find nothing professional, humane or dignified about premeditated murder.

# **News From Death Row**

Texas: On February 24th 2004 the Supreme Court overturned the death sentence of Delma Banks Jr. because he was denied a fair trial due to prosecutors in Texas failing to disclose key information. Banks was only minutes from his sheduled execution last year when the Supreme Court intervened. This decision remands the case back to a lower court so that new evidence may be considered.

South Dakota & Wyoming: Governors Mike Rounds of **South Dakota** and Dave Freudenthal of **Wyoming** have signed into state law bipartisan legislation banning the execution of those who were under the age of 18 at the time of their crimes. Of the 38 death penalty states, 19 forbid the death penalty for juveniles. The federal government also forbids the practice. Twelve additional states do not allow the death penalty at all. The U.S. Supreme Court will consider the constitutionality of the juvenile death penalty this fall when it hears arguments in *Roper v. Simmons*.

"Debating the Death Penalty: Should America Have Capital Punishment?," a new book edited by Hugo Bedau and Paul Cassell, brings together judges, lawyers, prosecutors and philosophers to debate the death penalty in a spirit of open inquiry and exchange. The book discusses issues such as deterrence, innocence, life in prison without parole, and race. In addition to the editors, those who have chapters in the book inlcude: Judge Alex Kozinski, Stephen Bright, Joshua Marquis, Bryan Stevenson, Professor Louis Pojman and former Governor George Ryan. Total cost of Indiana's death penalty is 38% greater than the total cost of life without parole sentences. A study by Indiana's Criminal Law Study Commission found this to be true, assuming that 20% of death sentences are overturned and resentenced to life.

# A View From The Inside An Inmate's Perspective By Greg K. (EaglesFan), an Ex-Inmate

Writing letters to inmates. It's a strange idea isn't it? For those of you that do it, thank you. For those of you that are thinking about doing it, please give it a try. The difference that one person writing one letter can make is tremendous.

Let's look at what a letter can mean to someone. When mail call arrives, it can either be the best part of the day or the worst. It can either brighten a dark and gloomy place or make it seem darker and more desolate. No matter what type of facility you're in; a county jail, a holding or transfer center, or the worst prison, mail can make a huge difference. When your name is shouted out during mail call, your heart speeds up, your mind begins to race and your day suddenly becomes tolerable. As you quickly look for a familiar name on the envelope, the feeling that you're not alone

anymore overtakes you.

When your name is shouted out during mail call, your heart speeds up, your mind begins to race and your day suddenly becomes more tolerable. As you pull out the letter and carefully read each word, the world outside your small confines become real again. As the news from friends, family or penpals pours from the page; you feel like you're a part of their lives once more. All of the struggles that you go through during the day fade away. You quickly begin to think about what to write back, what questions you want to ask and how

to say the things that you're thinking. You suddenly have something to occupy your mind, and that makes the time go faster.

If your name isn't called during mail call, you look dejectedly down at the floor and wonder what happened. Why aren't they writing? You try to look like it doesn't matter to you, but inside it's tearing you apart. You look with envy at the others who received mail, and wonder why people care about them and not you. You become bitter and angry. What might have already been a bad day becomes terrible. After several days of this, you begin to dread mail call, and the thought that recurs every day that no one cares about you.

In short, a letter can make a tremendous impact in someone's life. People that take the time to write someone that they don't really know are a unique group. The kindness and compassion that these people show is amazing. The amount of comfort and friendship that is transferred with the stroke of a pen can be a source of wonder for both the sender and the person getting their name called by the C.O.

Prison is an easy place to lose your hope and faith in people. It's an easy place to lose hope and faith in yourself. It's an easy place to become hardened against life and love, friendship and compassion. A simple thing like a letter can make a hardened person better, and quite possibly help save someone's life.

Many facilities have little or no phone contact. Letters might be the only window to the outside an inmate sees. Please help to open that window. Please make a difference to someone that feels like no one cares. Please let someone know they're not forgotten. When it's you on the receiving end of that letter, you have no idea what it means to have your name called.


# Pen Pals of The Month Inmates Desiring Mail

The same AOL article that captured many others curiosity, the famed "Susan Smith" article that many of us have given just the SS initials now when discussed.

That day out of curiosity I went to the website that housed SS's ad for a pen pal and was amazed. I had no idea that inmates actually could have ads for penpal correspondence! And one part of me was even mortified because I was also brought up with the thought that "All" inmates were bad people so they didn't deserve to correspond with "Us." But as I read through the ads out of curiosity, that was there I felt my first pangs of the majority of the feelings coming from the ads and that was an undeniable amount of loneliness.

I even scoffed at the idea of writing and finding a pen pal of my own....gee I thought I am not "one" of those people that would do this...but something drew me to that site and almost nightly I would visit it and read the ads. Eventually I came across one where this person sounded so very sincere and wanted just to write to another human and form a friendship. Pen in hand I wrote to this person, hesitantly but then with gusto and I mailed that letter out with my newly acquired P.O. Box address and waited with anticipation and even dread...did I do something wrong? Maybe I shouldn't have written to a "prisoner" I thought. During that wait I found the forums where I became acquainted with many wonderful and not so wonderful people but I found an immense amount of support, advice and even friendship from these people I had never met face to face.

Weeks went by and I never received a reply from the person I chose to write and was ready to scrap the whole pen pal idea. My newly acquired friends from the board said no even if you choose not to write stay on the board. So I did and the weirdest thing happened...I went to go look at an ad that a friend of mine said she was writing to and another man's ad came up and my computer just froze at that point. I couldn't get it to move, I was stuck! So in my frustration I kept pushing control/alt/delete to no avail and when I finally looked up at the ad my monitor was screwed up so I couldn't really make out this persons face but I read his ad and was like a rush of cold water was dumped upon me. Even though his sense of humor, his anecdotes and his description of his beliefs, I saw the underlying sadness that was there and I noticed his

birthday was a few days away so I said why not and sent him a birthday card. I never expected a response, but by the third letter...it was strange it was like I had known this man before but I didn't say anything to him or anyone. How could I? This person was in prison, not the type of thing you would bring up at dinner and say, "Hey Mom & Dad, my new boyfriend is in prison." But I remember it very clearly it was the day of the blackout in NY and I had gotten home in a bad mood, my dog had bitten the mailman (smile), my car got hit in the parking lot, and now I had no electricity, and it was a sweltering night! But sitting in my mailbox was an envelope with "Mail from an Offender" stamped across it and I stuffed it in my bag. That night as I read his letter by candlelight and it so deeply touched me and I responded to him with all the truthfullness in my heart. He will even say to you that those two letters that night were the change of our relationship. I realized that this is the person I was meant to be involved with as he felt the same way. It's not tangible what I felt reading and holding that letter but from that day on our relationship changed and has grown to what it is now.

I tried very hard to fight these feelings at first but in the end I have realized you don't find love, no matter where you look or how much you want it, you won't find it. When you least expect it, it will come and find you; if you are lucky enough to really see what it is before you then accept it with open arms but with a head screwed on tight. Yes my love and I have many hardships ahead but we also have many plans for a future. Not a future where we will constantly be doing this or that...just a plain, boring future where most of all we will just be together and grow old as one. For you see to my love and me the only difference between our relationship and having one with someone in the free world is the bars. And one day those bars will be gone.

#### Hey Anxiousgal,



Just be up front and again don't go beyond your means, it is very easy to fall into that and you have to take care of yourself first.




#### A Mismatched Pair of Gloves
