

## News From Around the Globe

### After 24 Years in Prison, Man Has a Reason to Smile

Marietta, GA.- It is rare to see a prison inmate with a life sentence who cannot stop grinning. But that was Robert Clark Jr. on Wednesday, the day before his conviction for rape, robbery and kidnapping was expected to be vacated on the strength of a DNA test that showed he was not the rapist.

After 24 years in prison - one of the longest incarcerations served by the 164 people who have been exonerated by DNA testing - Mr. Clark, 45, was buoyant at the prospect of seeing his siblings, children and the five grandchildren he did not have when he was sentenced in 1982.

Mr. Clark's story is not so different from that of others who were wrongfully convicted.

The DNA test that exonerated Mr. Clark started a chain reaction that revealed not just Mr. Clark's innocence, but a series of law-enforcement bungles. Those missteps allowed the real criminal to commit violent crimes repeatedly and, very nearly, to walk out of prison, where he is serving time for cruelty to children, at the end of January.

Thanks to finally checking the DNA evidence, Mr. Clark will be going home and hopefully the correct person will be staying behind bars this time.

### Schwarzenegger Appoints Physician as Prison Health Care Czar

SACRAMENTO (AP) - U.S. District Judge Thelton Henderson on Thursday gave Schwarzenegger one week to name a single person in charge of overseeing reforms to the health care system. He also criticized top Department of Corrections and Rehabilitation officials for failing to act quickly on reforms.

"They still fail to grasp the gravity of the crisis," Henderson said of managers in the state prison system, adding the emphasis in his 15-page ruling. He said he will no longer permit the department's top staff "to twiddle their collective thumbs" while conditions continue to deteriorate. Court-ordered reports have shown the system is responsible, on average, for the death of one inmate each week.

Peter Farber-Szekrenyi, whom Schwarzenegger named Monday as the prison system's new chief of health care services, also will work directly with the governor's office on reforms, said Schwarzenegger spokeswoman Julie Soderlund.

Henderson also ordered the state to immediately increase prison doctors' wages 10 percent a year and prison nurses' pay 18 percent a year. The department also must speed up hiring to fill 476 vacant nursing positions and 103 vacant physician positions. Prison officials also must accept or reject doctors' job applications within 10 days. Corrections department lawyer Bruce Slavin said it will be "a real challenge" to hire within 10 days because background checks take longer.

At a hearing Monday, Henderson said Schwarzenegger should find the money "the same way you find the money to build a tent to smoke cigars." Schwarzenegger had a smoking tent installed outside his office because state law forbids smoking in public buildings.

### Don't Discard Youthful Offenders

Children can and sometimes do commit terrible crimes, and when they do they should be held accountable. But life in prison without any possibility or even consideration of parole does not hold children accountable, it holds them disposable. Child offenders should be sentenced in a manner that reflects both the severity of their crime and their special capacity to change and redeem themselves.

A recent report by Amnesty International and Human Rights Watch reveals that 2,225 child offenders in the United States been locked up for life without

any possibility of parole. Fifty-nine percent of child offenders serving life without parole are in prison for their first criminal offense, and an estimated 27 percent were sentenced for felony murder, meaning they were involved in a crime during which a murder took place, but they did not take part in the murder itself. Sixteen percent of child offenders serving life sentences without parole were between the ages of 13 and 15 when they committed their crimes.

Are you the same person you were when you were 14, or 16? Neither are the child offenders who have been discarded into our prison system without any hope of release, but our criminal sentencing laws ignore this obvious fact. While a neuroscientist could explain to you the specifics of brain development, it doesn't take a doctoral degree to know that kids act out, often don't consider the consequences and are extremely susceptible to peer pressure.

Judges cannot look into a crystal ball at the time of sentencing. Children are uniquely suited for change: They grow up and mature, often becoming unrecognizable to those who knew them in childhood. Yet in many states, sentencing of children who have committed very serious crimes has become an exercise in fortune telling.

Ironically, in 28 states, even a judge with a crystal ball could not save a child from being discarded into our prisons for life. Instead, in these states, judges' hands are tied by mandatory sentencing laws. Children locked away for life, is yet another reason the US needs to take a serious look at mandatory sentencing laws.

### County Jail Is Being Sold on EBay

Along with concert tickets, sports memorabilia and designer handbags, add a Missouri jail to the list of things you can buy online at eBay. Randolph County, MO officials have decided to sell their old jail on the auction site as soon as Wednesday. Bidding starts at \$32,500, said Jim Myles, a county commissioner.

The two-story structure resembles a quaint home more than a secure lockdown. That's because until 1989, the jail doubled as home to the county sheriff and his family, with a separate living quarters including a full kitchen and fireplace. The sheriff's wife even cooked meals for prisoners.

### Salvation Army Helps Prisoners Give Their Children Gifts

St. Louis - A vacant store in a suburban shopping center was transformed into a makeshift Santa's workshop on Tuesday as hundreds of volunteers wrapped and shipped gifts to brighten the holiday season for the children of prison inmates. For more than a quarter century, the Salvation Army here has quietly helped prisoners send holiday gifts to their children in an effort to strengthen the bond between the incarcerated adults and their kids.

The holiday gift effort in the St. Louis region will reach more than 13,000 children in Missouri and southern Illinois this year. And while the Salvation Army talks about the \$90,000 and 900 volunteer effort in the abstract, it never specifically reveals to the children that it played a role in getting them the gifts."We want them to think it came right from their Mom or Dad," explained Major Marty Hudson, who coordinates the Army's Toy Lift Program, funded by the Salvation Army's Tree of Light campaign.

At prisons that opt to take part, a chaplain or activity coordinator provides inmates with a catalog prepared by the program. Parents can select a toy, from rattles for newborns to baby dolls or book lights for older children.

They fill out and sign a card, with messages simply saying "I love you" or even "I'll be home next Christmas," Hudson said.

After checking to make sure the gifts are headed to the appropriate children or stepchildren, volunteers take care of the rest. They match the selected gift to each child, wrap it, and ship it along with the card. The Salvation Army also works with a few juvenile detention centers, so that children being held can send their parents a gift.

## Death Row Capital Punishment Talk by Lene Gabrielsen (Cassi)

I have been writing someone on death row for over three years, and it has become such a big part of my life that it almost surprises me when I realize that new people I meet find it a little strange. Some people bombard me with questions about them and their cases and others just look at me like I'm from Mars (I think we have established that no one actually comes from Mars, so I figure there's no one who takes offense). In the very beginning I felt like I had to defend my friends on the row, and also my friendship with them, but as time has gone, I don't anymore. It's none of their business anyway, right? I am grateful of all the things each of them have taught me. That may sound like a cliché being that everyone that writes someone on the row have the GREATEST pals of all times. \*Smile\* But in the end of the day it doesn't really matter how everyone else feels, because I can only speak for myself. So, are you curious what they have taught me? Well, patience for one. No joke either! It is not only because mail works in its own mysterious ways and own time (or perhaps in mailroom time, and postal services time), but I have thought so many times that it takes patience and strength to wait like my friends have to wait. All they ever do is wait, wait, wait and wait some more. It takes time to get the case through the courts as all of you are painfully aware, but also wait for everything we take for granted in the free world. My vocabulary has increased a LOT the last three years. As many of you know, my native language is Norwegian, and I had never thought that I'd ever understand legal terms in English, let alone know more about the law in the USA than Norway. I have learned to appreciate the little things, such as walking barefoot in the grass and the sound of the ocean.

I have been asked how I can relate to the worst of the worst and if I am attracted to violence, or perhaps the bad boy image. First of all, I am SO not attracted to violence. All thought the crime rate is going up in Norway too, I have grown up in a very peaceful country, and here it is against the law to spank children. I'm just saying to prove a point how little I am attracted to violence. I guess that is one of the reasons why I wanted to reach out to someone on death row. I believe it is as violent as it gets when a country kills their citizens. To me the guilt question isn't a factor in choosing whom to write. I assume my friends are guilty until proven otherwise. Honestly, I don't give it much thought, because I am not here to judge. A judge and a jury took care of that factor. But I have come to learn that innocent men and women are in fact found guilty of crimes they did not commit.

I write two men I believe are innocent as in had nothing what so ever to do with the crimes of which they were convicted. I don't believe that because they told me so, I believe that because of the case papers I have worked my way through, and because of all the people I have had the opportunity to talk to regarding my friends' cases. I think it is very important that we on the outside don't claim innocence for our friends without doing some research first. I understand that many are sentenced to death even though they didn't pull the trigger, but being a party isn't being innocent. They might not be guilty, and they certainly don't deserve the death penalty, but to me an innocent person is someone who did something else and had no clue about the crime that was committed while doing so. I just want to urge people to check things more thoroughly before making statements that in the long run may do more harm than good. All right, I'm getting off my soap box right about now and get back to what I have learned.

I hug my kids more than I did before. My 13-year-old son may not thank y'all (the inmates) for that right now, but he might pass it on later. Speaking of my son, I have two sons and three daughters and they have learned a lot also. None of my children will grow up and support the death penalty, that much is already established. My children treasure the drawings and words of encouragement my friends give them, and I am so grateful for the unexpected help in raising them. All parents want their children to stay out of prison right? Well, I don't think any of mine will end up there. I guess that I'm trying to say that your journey till now hasn't been all for nothing. You are touching lives, and you do it from man made hell. I also write some that are serving time in general population, and everything I have said also applies to you.

As for me being attracted to the bad boy image, I don't know any bad boys. \*Smile\* I know some boys that I have to correct every now and then, because their behavior is a little bad, but they are seven and thirteen years old and are my children. Other than that, I know men who messed up their lives one way or another and are paying a tremendous price. Mother Theresa said if you judge people, you have no time to love them. With that, I'm going to close for now.

Oh wait, I have one more thing to say! Feel free to send suggestions what I should write about. If you don't, I'm left to chit chat on my own, and if so, it is your fault if you fall asleep. I'm not sure if it says so in the disclaimer, but it is in Cassi's disclaimer. \*Smile\*

Have you ever come to your senses in the middle of something that seemed like a dream to realize you haven't been dreaming at all? That's my life these days. Since my column LAST December, I've been...well...for lack of a better term, slacking.

My pals have suffered the brunt of my 'laziness' and quite frankly, I'm shocked that all have stayed around and supported me while my life changed in so many ways. Even through my silence with them, it was never a lengthy time without a card or letter from one of them asking me how I am and wishing me well at whatever I was doing. It wasn't until I got an eye-opening letter from my one of my pals that I realized what I was doing not only to them, but also to myself. I was 'ignoring' a huge part of my life and one of the main reasons I was able to smile during the last (almost) 4 years.

Don't get the wrong idea – my life changed in mostly good ways, so I wasn't sitting on my sofa stuffing my face with bon-bons while watching reruns of The Golden Girls. I have been out living a life I never knew and getting to know who I was again. I missed that woman and am proud to say she's back in full force. Remember the Tropicana train cars I raved about in my last column? Well they are still there and I am still in awe at their embellishing beauty. Go ahead and laugh because I am!

Through my lack of words and writing hiatus, I have missed my pals terribly – their kind words; their shoulders if I need to vent or cry; their uncanny ability to make me laugh; their unconditional love, support and friendship; and their understanding when I wasn't feeling like myself. They have been my angels in disguise and have no idea how much I appreciate them. I care about them more than I can express in mere words.

Now as I look back, I didn't think I would find an honest-to-goodness smartass that I consider one of my best friends; a bear with a heart of pure gold; an Army veteran and artist whom I adore; a true Southern gentleman whom I've promised to cook a country breakfast for once released; an amazingly sweet man with tons of tips and tricks up his sleeve - especially for making homemade wine; and my fiery Latino that knows just how to push my buttons to make me think on a regular basis. I have a few others with whom I occasionally correspond, and they too are highlights to my days. As wonderful as these men are, why on earth would I risk the chance to not know them by being selfish by keeping my life to myself? Sometimes our lives get the best of us and we forget the people we need until it's too late. I am thankful that letter from my pal came to me before it was too late to salvage my friendships.

I suppose this isn't good PR for the owner of LostVault to admit she slacked in writing her pals when she was there in the forums telling people to pick up their pens and write an inmate. I am human and make mistakes, get caught up in myself once in a while, and forget sometimes about the very things that make me truly happy.

Don't be like me – don't let your life consume you even momentarily and ignore the friends you've made behind bars. They need you and admit it, you need them too.

Before I go any further, I would like to give my sincere and deepest heartfelt thanks to "ALL" out there fighting for our country! Also to LostVault for letting me attempt to grab folks attention to many possibilities.

There are those of us here in prison that will eventually go back to our communities. Some of us will go home sooner that others. There are those of us, who are in prison behind such unfair & miscellaneous convictions. And even those of us who are rightfully in prison. But most of us will have a chance to go home. At that is where my issue is at.

I'm not sure how much it cost the tax payers each year to house inmates in the state of Texas. I do know that there is over a 150,000 inmates in the Texas system right now. I believe at least 1/2 of them will be released at some point. Now, this war in Iraq is also costing the tax payers. Their money is steadily going towards inmates at the same time. Why is it that the Government don't take inmate, and train them to help fight this war?

The Army & Marines are perilously overextended by the war in Iraq. The Army already has lowered it's standards to let in more high school dropouts! Also, Marines are offering as much as \$30,000 to anyone who "reenlist"... Defense manpower officials concede there are critical shortages of military personnel with certain special skills, such as medical personnel, linguist, computer network engineers, etc.!

The Army needs more soldiers, not just more doctors & linguist. What they got now is a real shortage of "GRUNTS"- guys who can actually carry bayonets. We have to have a bigger Army.

As the new columnist for *LostVault: Unlocked's* "Romance Column", I feel honoured to have been asked to step into this role after the untimely passing of our very special and intuitive former columnist 'Dear Libbie'. I thought I'd dedicate this issue's column to introducing you, the reader, to a little about myself and as well share some creative ideas on celebrating the holiday season with your incarcerated loved one.

At 32, I can with absolute confidence say that I've lived quite an extraordinary life. In short, I'm a daughter, a sister, an ex-wife, a mother, a career woman and above all else I'm a friend to all and yes, even a special someone to an incarcerated individual. I, like the vast majority (if not all) of our readers, have experienced love in varying degrees. I have experienced love relationships both in the free world and with someone incarcerated. Understanding and bridging the differences and the similarities in the two relationships has become my passion and my quest that I look forward to continually exploring and sharing with you. I'm an eternal romantic, but an emotional realist. I'm a spiritual woman, but I am not religious. I believe there exists good and bad in all things and I embrace it all equally and open-mindedly. My ability to recognize the accomplishments as well as the challenges of any situation I believe keeps me level-headed and non-judgmental. These are the qualities I possess and hope to bring to the eye of our readers through my articles.

Very few can ever truly relate to the emotional pain of being torn apart from their beloved. Everyday relationships are frequently taken for granted. When tragedy strikes, we so easily and naturally give solace to those separated from lost loved ones be it to events such as death, war, or even divorce. Who is really there to comfort us when the loved ones are lost in/or to prison? An emotional constipation seems to all too often befall our closest support systems; our family and our friends. However, from the other end of the spectrum, how do you console someone when you don't understand how they can deeply love someone society has deemed a guilty person, a human unworthy of our freedom? I'm a firm believer that our emotional grassroots should include the philosophy that in life, everyone that lives and breathes needs love and understanding.

## Love is *AFFECTION*. Love is *KINSHIP*. Love is *BENEVOLENCE*. Love is *LOYALTY*. Love is above all else *UNSELFISH*.

Understanding is *ACCEPTANCE*. Understanding is *SYMPATHY*. Understanding is *TOLERANCE*. Understanding is *THE POWER OF COMPREHENSION*.

We can clearly see, in simple black and white text, how magnificent two little words can be. Yet, in the world of a prisoner, these two are often merely a pronounceable series of letters or functional nouns, verbs and adjectives. This coinage is false and untrusting to them, only carrying emptiness, loneliness and rejection into their heart and soul.

So, as the holiday season approaches, show your incarcerated loved one(s) just how much LOVE and UNDERSTANDING you have for them. What ways can you think of doing this? Here are some alternative suggestions to the usual fare of money orders, phone calls, or gift packages (bear in mind your budgetary limits and the rules & policies of the facility in which your loved one is incarcerated).

1. Send a sheet of paper with a Christmas tree outline and another with varying ornament shapes for them to tear out. Decorate the ornaments or embedding photos of you, the family, pets, friends, etc. right on them. Help them to be able to decorate their own "tree" in their cell and share the day with you in spirit.

2. Utilizing the "Twelve Days of Christmas" theme, send a letter every day counting down the 12 days before the last mail delivery day before Christmas. On the twelfth day of Christmas (your first letter sent) list 12 of both of your favourite things you'd love to do together; for the Eleventh day (your 2<sup>nd</sup> letter) take 11 photographs of their favourite things and send them in, and so on with something new each day until the first day of Christmas (your 12<sup>th</sup> letter) in which you send a very detailed, special and heartfelt message about your favourite moment with them since you first met.

3. Send your letters written or typed on paper of your loved ones favourite colour, Christmas colours (alternating pages) or XMAS theme.

4. Get a picture on Santa's knee at your local mall and send it to them. Don't forget to draw an arrow pointing at Santa's empty other knee and write "This spot reserved especially for you".

5. Buy a fine-tip permanent marker and a deck of poker cards. Each day take a card out and write a short sentimental note on the face of the card and mail it to them. Fifty-two days later, and they'll have a complete deck special notes from you. Whenever they are feeling lonely, all they have to do is take out the deck of cards and play solitaire to be constantly reminded of how much you love and care for them.

6. Arrange a dedication and playing of their favourite song on a local radio station that your loved one has access to.

7. Send your sweetheart a day-by-day tear-off calendar of 365 reasons why you love them. Make every reason personalized to some type of inside joke or something that relates to you both.

8. Buy 25 cards, (serious & funny), for each day of December leading up to Christmas Day. Send one card a day.

9. Have a T-shirt custom made with your loved ones name &/or picture printed on it. Wear the shirt out and have someone take a picture of you. Send it attached to a decorative hand made paper frame.

10. Visit a website full of quotes and phrases. Buy a little one-year blank diary (or just use regular  $\frac{1}{2}$  sheets of stationery paper). Write a quote at the top of each blank page and then I explain on the rest of the page why you chose it. Find 365 quotes and only choose special, meaningful ones. Plan on sending in the pages as a Christmas "present" so they can start reading them on January 1<sup>st</sup>.

11. Write a letter to your significant other telling them the things that you are looking forward to in the coming year and them one to you. Seal them each in an envelope and marked "Do Not Open until Next XMAS". Once they are exchanged, tuck them away for safekeeping. These are kept sealed for a year. Then next year, on the holiday, you both open and read the letters - it's sweet and romantic and fun to see what things were predicted for the two of you and to see how much did actually happen. It's a great way to reminisce about the year! For the first year you write one letter for the coming year, and one letter for you to read this year that can be about anything - write about what that first year was like together and what your favorite memories were.



#### **CHRISTMAS** Who is the poinsettia named after?

The poinsettia was named for Joel Poinsett, a U.S. ambassador to Mexico, who introduced it to the United States from Mexico in 1829.

An advertising employee at the department store Montgomery Ward wrote the story in 1939 for a store promotion. The store gave away 2.4 million copies of the story to its customers that year and it's been part of American popular culture ever since.



### HANUKKAH

The holiday, celebrated Dec 26 this year, is the Jewish festival of lights. It originated when Judah the Maccabee and his followers reclaimed the temple in the village of Modi'in from Syrian King Antiochus IV. The temple was cleansed and prepared for rededication. The Hebrew word Hanukkah means "dedication." When the sacred temple Menorah

(candelabra) was relit, there was only enough sacred oil to burn for one day. Yet, according to tradition, the oil miraculously lasted eight days until more purified oil could be found.

The Hannukah Menorah has 8 candles to signify the 8 days that the miracle oil burned. It is lit from the middle, 1 candle per day, and displayed, for the 8 days of Hannukah.



### KWANZAA What does Kwanzaa mean?

Kwanzaa, celebrated from Dec 26 to Jan 1, is Swahili for "fresh fruits." The holiday is based on African harvest festival traditions and was created in 1966 as a nonreligious celebration of family and social values for African American families.



### MUSLIM

Eid ul-Adha will be celebrated Jan 10, 2006 by Muslims all over the world as a tribute to those who will be completing their pilgrimage in Mecca on that day. On this day Muslims sacrifice animals which have been deemed fit for sacrifice. They not only eat the meat themselves but distribute it amongst their neighbors, relatives and the poor and hungry.



## ight angle How to Solve Crypto-Families $\langle$

Each Crypto-Family is a list of related words in a simple substitution code in which a different letter of the alphabet is substituted for the correct one.

The words in a Crypto-Family list are related to a single theme or category indicated by its title. The example given is a clue to the kind of words to expect in the list and will help you guess what some of the words are. To break the code, look for words with distinctive letter patterns, such as repeated or double letters. For example, in a list of American Presidents, if an entry reads "Z B W D R B D," it is a 7-letter word with the same letter in the second and sixth positions and another letter in the fourth and seventh positions (the answer is JOHNSON). When a word in the list is correctly identified, use the decoded letters to help decode other words in the Crypto-Family. If D stands for N in one word, it will stand for N in all the words in that Crypto-Family.
